"A FEW THOUGHTS ON MASONIC RESPONSIBILITY!"

Yesterday, our Master asked me to write a short piece for this month's Trestleboard as he was at overwhelm with some of his personal responsibilities. This I gladly agreed to do.

I had already been thinking earlier about the current chaos in Iran and how it might be affecting our Masonic Brothers of the Grand Lodge of Iran in Exile, and it occurred to me that we American Masons may not fully appreciate the freedoms we currently enjoy in our great country.

I'm sure our Iranian brethren in exile look upon the freedoms we native born Americans very often take for granted with a far greater sense of appreciation and respect. As I perused the local and national TV news and saw the usual daily fare of

political graft, outright theft, ethical breaches of public trust and fidelity, general lack of morality and the other problems our modern society is afflicted with, I thought "Here is an opportunity to put our Masonic principles to work for the public good to practice what we preach. We talk the talk, now is the time for us to walk the walk!"

We Masons profess to have higher standards of behavior by virtue of our various obligations; not only to our Brothers in Freemasonry but to our families, our communities, to our nation and, for that matter, to humankind in general we swore more than one oath to do these things, oaths sealed with our very honor and with terrible consequences for betraying that sacred trust!

Perhaps it is appropriate at this time of international unrest -- considering the problems in North Korea, Iran, Iraq, Afghanistan and elsewhere (Including the United States and its current fiscal crisis) for Masons to take the lead in demonstrating to the world that morality and ethical behavior are not outdated or flawed concepts -- useless in a dog-eat-dog world.

We Masons are proud of our historic roots and American Masons in particular, lay claim to an even greater heritage of democratic idealism -- American Masons helped draft our Constitution and its Bill of Rights - perhaps the greatest testament to man's ideal nature ever written to govern a young Republic and its free population.

At the conclusion of the Constitutional Convention in Philadelphia on September 17th in 1787, as Brother Benjamin Franklin was leaving the hall where the delegates had been meeting all that long, hot summer, a woman was said to have asked Franklin "Sir, what kind of government do we have?" and Franklin was said to have replied, "A Republic, Madam, if you can keep it!" A wise man was Brother Franklin; knowing that there would be a price to pay for a young nation embarking on such a bold social experiment.

The price for good government in a republic is the active participation and total involvement (and oversight) of good people. Just as a healthy and happy Masonic Lodge requires the active participation of EVERY member -- from the "newest Entered Apprentice in the North-East Corner of the Lodge to the Worshipful Master in the East," so do our Nation's affairs require the active and informed participation of ALL its citizens; if it is to function as our founding fathers intended!

It was Plato, I believe who said that "the price good men pay, who fail to participate in their government, is to be ruled by inferior men" - We Masons must be in the forefront when it comes to participating in our various political processes -- from the Lodge management to our Federal government -- demanding that our political and social leadership act with morality, honesty and openly espouse those virtues every Mason (if he is a true Mason) holds sacred -- Brotherly Love, Relief and most of all, TRUST! Failing to do so, we will likely find ourselves in the same position as those present citizens of Iran -- fighting in the streets for honest elections and an ethical and responsible government of the people, by the people and for the people!

God bless these United States of America and may God help the good people of Iran to someday enjoy similar freedoms as we now have in this country."

FROM THE WEST



FROM THE SOUTH

Greetings brethren, this is my first column as Junior Warden. In future entries, I plan to write a series about the seven arts and sciences of the staircase and what they mean to Masons, something I hope you will find interesting and not overly academic. However, for my first column, I feel it is appropriate to share with you some of the things I learned at the recent Junior Warden's Retreat.

This conference was exceptional in the enthusiasm of the speakers and the value and relevance of the information provided. The sessions provided a clear overview of the state of California lodges today, as well as their challenges, opportunities, and problems. Here are a few facts and ideas that our lodge should take notice of and consider:

California has about 58,000 active Masons. We expect to bring in about 1600 new members next year, but will suffer a net loss of over 2300 to death of older members--we're losing far more members than we're adding. Our lodge is doing a great job of bringing in new, promising Masons, but we need to keep in mind that failure to grow means that our organization will continue to dwindle.

Due to these numbers and adverse economic factors, our per capita contribution to Grand Lodge will increase from \$31 to \$33 in the next budget. Next year's Grand Master suggests that we go over the reasons for this within our lodge as soon so our membership recognizes the need to support this increase. It's important to note that Grand Lodge made significant budget cuts so that the increases were not even higher.

One speaker suggested that if we have members who are currently living too far away to attend many meetings, but who want to maintain their connection to the lodge, we should consider ways to let them participate through new communication technologies--contributing to our website and other Internet activities, or giving them tasks that could be done by phone--keeping in touch with our widows, for example.

Grand Lodge officials have noted that thousands of older Masons have been suspended because of nonpayment of dues, despite having been active members for decades. One reason for this may be that sick or infirm members have turned over household bill management to their wives or relatives who may have declined to pay dues because the members are no longer able to attend lodge. The recommendation is that we make sure all wives of older masons fully understand the valuable benefits to widows of Masons who die in active status. I learned a lot about the Grand Lodge's widow's outreach program that I never knew. We should make sure all members and their wives are fully informed on these points.

Finally and most importantly, one exercise poised this situation: Assume a young man interested in our lodge says to you, "I hear Masons make good men better. What specifically does your lodge do to make this happen? What programs do you have in place for this purpose? What specifically do you expect of me?"

Up until a year or so ago, I'm not sure I could have given a completely satisfactory answer for how Culver City-Foshay provides this guidance. However, since then, I believe that we have, as individuals and collectively, improved our ability to fulfill these needs in our incoming members. Certainly, the fact that so many first and second degree members are turning up at lodge functions suggests that they feel we are providing something of value. Still, I ask that each one of you think seriously about how you would answer the above questions, and if you feel that any of your answers are inadequate, please come up with suggestions for how the lodge could improve its offerings to our future and current members. It's food for thought.


