




Greeting Brothers.




Masonic Gatherings




On Heavenly Bodies





Report from Finance Committee



Brethren of Culver City-Foshay Lodge #467, F&AM:

At the direction of our 2012 Worshipful Master, Masato Francis Taguchi, a special finance committee was commissioned in early 2012 to review 5-years of previous lodge budgets, dues history, and project a 5-year forward solution necessary to cover many years of substantial budget shortfalls. The committee conservatively projects at least 64% of the shortfall will be covered in the next 5-years with the enactment of the recommendations below.

This committee has unanimously voted the Lodge pass two By-Law Amendments for Fees and Dues increases. Beginning 2013 we also have also unanimously recommend a Standing Resolution be enacted that members of the Lodge may take advantage of a Lifetime/Permanent Dues Payment Option per California Masonic Code, a goal of the Worshipful Master.

The Lifetime Dues program is a financial "win-win" for both the long-term fiscal solidarity of the Lodge, and a benefit to members. It allows members to pay a sum equal to 20.83 times total dues (approx \$120 should the Dues Amendment below pass, thus a total of \$2499.60). One very special caveat is that any member may pay their 2013 Dues, and decide at anytime up to December 31, 2013 to contribute the remaining balance required to become a Life Member.

Benefits to the member and his family:

- No annual dues to pay
- Not subject to future dues increases
- Cannot be suspended for non-payment of dues
- Maintains good standing status &eligibility for fraternal support & benefits:
 - Relief provided by the lodge
 - Masonic Outreach Services for himself, his family, and his widow
 - Admission to the Masonic Homes for himself and his wife or widow, and his mother in special circumstances
 - Masonic funeral availability
 - Scholarships that might require a Masonic relationship
 - Membership in a Masonic organization that requires a Masonic relationship
 - Pride in doing something special for his lodge by providing a legacy in perpetuity

Benefits to the lodge:

- Avoids suspension of the life member for non-payment of dues, provides member retention benefits, and helps prevent the member from demitting from the lodge.
- The funds remain in the life membership account in perpetuity after the life member dies, providing income and contributing to the financial viability the lodge long after income from his dues would have ceased.
- Develops a fund which, if properly invested, can help provide financial stability and sufficiently grow to provide an annual income to the lodge equal to or greater than the dues that the member would have paid if he had not purchased a life membership
- A well-developed, invested, and maintained life membership fund can assist in long range financial planning and the development of future programming for the lodge.

Further details on these benefits, including a 5-page Grand Lodge Document, "Lifetime Membership Program Examined", may be obtained from finance committee chairman, Brother Michael Hartman at the email address below. Brother Hartman very much welcomes comments and questions regarding the proposed changes and will share them with the Finance Committee and the Worshipful Master.

Per Grand Lodge requirements that the Brethren of the Lodge have due notice 30-days in advance of the votes, requiring a 2/3 majority to pass, to be held at the July 11, 2012 Sctated Meeting of Culver City-Foshay Lodge #467 F&AM for the two By-Law amendments, the exact proposals read as below. Keep in mind that the 2012 Per Capita was \$35, and it historiccally is increased approximately \$1 per year, thus the total cost per member for 2013 dues will likely be \$120 or \$121. Also, note that Grand Lodge requires new initiates to contribute to its charities (i.e. Masonic Homes, etc.), in addition to our lodge degree fees. The current sum of those fees is \$94.

BY-LAW CHANGE PROPOSALS CALIFORNIA MASONIC CODE § 802.020, ARTICLE III – FEES AND DUES, SECTION 1 (FEES)

This is to certify that at a Stated Meeting of this Lodge held on the date of May 2, 2012, the following Amendment to Article III, Section 1 of The Uniform Code of By-Laws of Lodges was presented in writing and noted upon the minutes of the Lodge:

The table of fees for this Lodge shall be as follows:

A. For the degrees, the sum of \$300.00;

B. For the degrees of Fellow Craft and Master Mason, when the Entered Apprentice degree has been received in another Lodge, the sum of \$200.00; C. For the degree of Master Mason, when the Entered Apprentice and Fellow Craft degrees have been received in another Lodge, the sum of \$100.00 and; D. For affiliation the sum of \$55.00 [X] Exceptions: The affiliation fee shall be \$0.00 if the Demit accompanying the application is issued by [X] this Lodge, [X] a Lodge in this Jurisdiction. ...

CALIFORNIA MASONIC CODE § 802.020, ARTICLE III – FEES AND DUES, SECTION 2 (DUES)

This is to certify that at a Stated Meeting of this Lodge held on the date of May 2, 2012, the following Amendment to Article III, Section 2 of The Uniform Code of By-Laws of Lodges was presented in writing and noted upon the minutes of the Lodge:

The dues of each member of this Lodge shall be the sum of \$85.00 per annum, plus the Per Capita sum approved by Grand Lodge at the immediately preceding Annual Communication, payable in advance on the first day of January.




